



## INFORMATION LETTER

**Caspian University Adilet Law School** is delighted to invite you to participate in the *International Scientific-Practical Conference of Students and Young Scientists within the framework of the Annual Bassin Readings "Current Issues of Private Law"*.

The Conference of Students and Young Scientists within the framework of the Annual Bassin Readings "Current Issues of Private Law" will be held on **19 April, 2024**, both online and offline. The beginning is at 10:00 a.m. Almaty time.

The link to the conference and the access code will be additionally sent after **19 April, 2024**.

Working languages: Kazakh, Russian, English. Form of participation – **full-time, remote (online)**.

**The address of the conference organizers is the Caspian University (85A Dostyk Avenue, Almaty).**

**The conference will be held at Caspian University (3rd floor, large conference room, 85A Dostyk Avenue, Almaty).**

The Organizing Committee of the conference asks you to send a topic of the report and information about yourself in English for inclusion in the conference program by **15 April, 2024**. For inclusion in the conference program – information on authors should be in English and contain full name, place of study (university, faculty, year), mobile phone of the author, e-mail address. Students, postgraduate master's and doctoral students need to specify the full name, academic degree and title (if any) of their academic advisers.

In the information on authors, participants must specify the format of participation:

- **a listener, without a speech and sending a scientific article;**
- **with an oral presentation, offline and sending a scientific article;**
- **with an oral presentation, online on the Zoom platform and sending a scientific article;**
- **no speech, only sending a scientific article.**

**The conference is intended to cover the following issues:**

- current issues of civil law;
- current issues of housing law;
- current issues of family law;
- current issues of labour law;
- current issues of private international law;
- current issues of corporate law;
- current issues of the law of obligations;
- current issues of contract law;
- current issues of intellectual property law;
- current issues of patent law;
- current issues of comparative law.

### **Information for participants**

One should submit an electronic version of the report/scientific article (designed in accordance with the requirements) to the organizing committee by e-mail in order to participate in the conference. Reports shall be accepted in Kazakh, Russian and English languages until **15 May 2024 inclusive**.

**Students, postgraduate master's and doctoral students provide a review from their academic advisers. The scan of the review should be sent together with the report/scientific article of the participant.**

Participation in the conference is free of charge. The proceedings of the conference will be published.

### **The following requirements are imposed on the design of reports:**

Volume of the article, including the list of references should not exceed **12 pages** of printed text. The minimum volume of the article is **5 pages** (without abstract and keywords). All pages of the article should be numbered. The UDC code must be indicated.

**The abstract** should be placed at the beginning of the text (**necessarily 8-10 lines**). Before the abstract, you should write your surname and initials, your place of work/study (university, department, course) and the title of the article. Then the keywords at the bottom of the abstract.

The abstract is a summary of the content of the scientific article. **Keywords** should provide the most complete disclosure of the content of the article; it is necessary to specify 5-10 keywords.

The text must be typed in Times New Roman, A4 paper size (210x297 mm), font size - 12 pt. Line spacing – single. The text is aligned to the width. Indentation - 0.8 cm. Page margins: top - 2, bottom – 2, left - 2, right – 2.

The text should not include hidden formatting characters. The text should not be framed, in tables, or in other objects that have visible or hidden borders.

### **A scientific article should not contain graphs, drawings or photographs.**

The list of sources is given at the end of the main text with one line indentation.

**References to sources in the text of the article are given only in square brackets (without citation [1], when quoting or retelling the author's text [1, p. 29]).**

**When making references in the text, punctuation marks (dot, comma, colon, semicolon, etc.) are placed after square brackets. For example: [1, p. 29], or [2, p. 30].**

The numbering of references in the article is carried out according to the ordinal number of the source in the list of references. The numbering of references in the article is made as the source appears/is used in the text (starting from 1, 2, 3, ... etc.). **One source is numbered once.** Archival materials are not included in the list, references to them are placed in the text in round brackets.

The bibliographic record of the source and a link to a network resource with a full network address on the Internet shall be provided in the list of references when electronic resources sources or remote access (Internet) are used in the article. It is recommended to specify the date of access to the resource.

FOR EXAMPLE (bibliographic information):

**For books:** Surnames and initials of the authors. Title. – Information about reprinting. – Place of publication: Publisher, Year of publication. – Total number of pages in the book.

*For example:*

Bassin Yu.G. Selected Works on Civil Law. – 3rd ed. – SPb.: 2003. – 294 p.

**For articles from journals:** Surnames and initials of the authors. Title of the article // Title of the publication. (Series). – Year of publication. – Volume. – Number. – Pages where the article is posted (from the beginning to the end of the article).

*For example:*

Bryzgalov A.I. On Some Theoretical and Methodological Issues of Legal Science at the Present Stage // State and Law. – 2004. – № 4. – P. 17-22.

**For materials of conferences, collections of papers, etc.:** Surnames and initials of the authors. Title of the article // Title of the publication: Type of publication. – Place, year of publication. – Volume. – Number. – Pages where the article is posted (from the beginning to the end of the article).

*For example:*

Didenko A. Civil Law as a Source of Legal Reality Formation // Civil law VI: Articles. Comments. Practice. – Issue 40 / Edited by A.G. Didenko. – Almaty: Rarity, 2015. – P. 4-24.

### ***Schematic example of article design***

• UDC.

• In the center are:

- Surnames and initials of the authors (e.g.: I.V. Ivanov, S.P. Krylov)

- Full name of the institution that the author represents (indicating the country and city). If the authors are from different institutions, then the correspondence between the author and the institution is established by superscripts, for example:

I.V. Ivanov<sup>1</sup>, S.P. Krylov<sup>2</sup>

Title of the article (bold)

• Abstract.

• Keywords.

• The text of the article.

• Bibliography (list of sources used).

**Scientific articles will not be published, if they do not satisfy the requirements for design and content. The main content of the article should not have been published anywhere before, it should correspond to the topic of the conference, have relevance and scientific novelty.**

**All scientific works of the conference participants are checked for the presence of borrowed material and the use of text with synonymous replacement of words and expressions without changing the meaning (paraphrase), including the use of text translated from another language (borrowing).**

All scientific articles will be checked by the organizing committee for plagiarism using the program Antiplagiat.ru . The uniqueness of the text of a scientific article should be at least 60%.

When writing an article, students, postgraduate master's and doctoral students should not allow:

- copying materials from the Internet without citing sources, providing someone else's work in whole or in part as their own, and other forms of dishonest work;
- using someone else's text with some minor changes in sentences and applying it as their own. Even if the words are different, the original idea remains the same, and this is plagiarism;
- the use of various technical means and techniques to reduce or eliminate the possibility of detecting that someone else's text has been illegally borrowed;
- auto-plagiarism, the author's repeated use of a significant part of his previously published work without reference to the source;
- fabricating data, inventing data and research results.

*To the attention of students, postgraduate master's and doctoral students!*

The Organizing Committee will select the best reports (1st, 2nd, 3rd place), which will be awarded with certificates and valuable prizes.

According to the results of the competition, the winners will be announced, the awarding of which will take place offline at Caspian University (Academic Council Meeting Room, room 011).
